NOTE: TX Transportation Code 550.065 allows release of a crash report upon written request and payment of required fee to any person directly concerned in the accident or having proper interest therein, such as an authorized representative of a person involved, driver, employer, parent or legal guardian of a driver, owner, someone with financial responsibility for a vehicle involved, insurance company, anyone who may sue because of death resulting from the accident, etc. To obtain a copy of an accident report you must provide at least two (2) of the above three (3) fields of information. The fee for a copy of the officer's report is \$6.00 (free for the owner/driver) and may be certified for an additional \$2.00.

Código de Transporte de Texas 550.065 permite la publicación de un informe de fallo previa solicitud por escrito y pago de la tasa exigida a toda persona directamente interesada en el accidente o tener buen interés en él, como un representante autorizado de una persona involucrada, conductor, empresario, padre, madre o tutor legal de un conductor, propietario, alguien que tenga la responsabilidad financiera por un vehículo involucrado, compañía de seguros, quien puede demandar a causa de muerte derivada del accidente, etc.
