

# Fiscal Responsibility

The Beaumont Police Department commits to stewarding taxpayer dollars well. Through disciplined fiscal management, in 2021, BPD provided year-round, 24/7 police services at a cost below the amount budgeted by city leaders.

In Fiscal Year 2022 (beginning 10/1/2021 and ending 9/30/2022), the budget for the Police Department is \$42,488,800. This comes out to 30.4% of the \$139,895,900 city budget. The Police Department is one of the largest departments in the city; with 260 sworn personnel and 64 full-time civilian employees.

Approximately 90% of the department budget is spent on personnel salaries and benefits. The budget is managed by Budget Manger, Lieutenant Kelvin Wilson.

## Internal Affairs

This unit investigates all formal complaints filed against Beaumont police officers. Texas law specifies complaints against officers must be submitted in writing, and must be signed by the complainant. Additionally, the unit also gathers and presents for review evidence in all incidents involving use of force, police vehicle accidents, and administrative inquiries.

# Property and Evidence

Any evidence recovered in a criminal investigation is secured and preserved by this unit. The Property and Evidence unit also stores and disposes of property via court order. Additionally, they maintain all uniforms and accessories for the 260 sworn personnel. The total intake of items was 11,247. The unit destroyed 933 items. Contraband, abandoned property, and items with unknown owners are among the items approved for destruction. When items are seized, they are due to be destroyed or (more rarely) used within the police department. 119 items were seized in 2021. 611 items were released back to their rightful owner.

### Records Unit

The Records Unit processes, files and maintains police reports, and generates the monthly crime statistics filed with the Department of Justice. In 2021, the Beaumont Police Department began reporting statistics under the National Incident Based Reporting System (NIBRS) guidelines. Additionally, the unit manages Tele-Serve reports, offense reports, case protective orders, and trespass affidavits. The unit also handles permits for commercial and residential burglar alarms, sets up new accounts, and processes false alarms. Finally, the unit fills all Freedom of Information (open records) requests.

## SWAT and Hostage Negotiation

Along with their regular duties within the Beaumont Police Department, 26 officers commit to extra training and physical fitness requirements to serve on the SWAT team. This team is on 24 hour call to assist officers in high-threat situations. SWAT is also aided by the 11 member negotiation team that responds to hostage/barricade situations. The vast majority of their calls for service are resolved peacefully.





### Training and Personnel

In order to have the most professional and highly-trained officers possible, this department exceeds the minimum training requirement set forth by Texas state standards. In 2021, they covered 160 topics. Between classroom instruction at the station and tactical training, 1,576 officers from the Beaumont Police Department and regional agencies received 25,937 hours of training. They also hosted two Lamar Institute of Technology Interns for the law enforcement intern program.





### Media and Community Outreach

The Police Community Relations (PCR) Unit is the center for media relations, community outreach, and volunteer programs. PCR officers are also mental health liaisons with Spindletop Center — Southeast Texas' community mental health center. PCR officers are also contacts for both the neighborhood associations and crime stoppers program.

Throughout 2021, the PCR Unit engaged with the community while adapting constantly to the shifting landscape of the COVID-19 pandemic. They educated the public through trainings and public presentations to a wide variety of groups. Through media partners and social media efforts, PCR provided transparent communication and kept the community well informed. Media platforms continued to prove valuable as they resulted in tips that solved cases and identified subjects.



### Cops and Kids

PCR held three Fun Day in the Park events at Alice Keith Park, Central Park, and Magnolia Park. These events work to build stronger relationships with the community and area neighborhoods. The annual Trunk or Treat event had a successful turnout of more than 2,500 community members. Furthermore, PCR impacted the community through Santa in Blue, Beaumont Police Explorers, Beaumont Police Museum and the School Reading Project (K-2<sup>nd</sup> Grade)

### **Mental Health**

There are 52 officers who are Certified Mental Health Peace Officers. These Mental Health Officers conduct weekly follow-ups and wellness checks on previous Emergency Detention Orders. During these follow-ups, officers ride along with a Qualified Mental Health Professional and provide assistance to these citizens with mental health disorders.



# Office of Emergency Management

The Beaumont Police Department oversees and coordinates the City's Emergency Management (EM) program and the Emergency Operations Center (EOC).

2021 brought many new factors to the Office of Emergency Management. The office welcomed a new Administrative Assistant and EM Specialist. The office saw the appointment of a new director of Emergency Management with the new Mayor, Robin Mouton.

#### Response:

- Provided logistical and operational support for Covid-19 vaccination, infusion and testing centers.
- Responded to Winter Storm Uri from February 13-17 and Tropical Storm Nicholas from September 9-14.

#### Training & Exercise:

- Taught 33 courses to 374 participants. In all, 2,586 hours of training for City and Regional personnel.
- Worked with FEMA, federal, state, and regional agencies to complete an emergency plan for complex terrorist attacks.

#### Recovery:


- Facilitated financial recovery from tropical storm Harvey (DR4332), tropical storm Imelda (appeal pending), Covid-19 (DR4485), Hurricane Laura (DR4572), and Winter Weather (DR4556)
- \$119,000 total reimbursement for four major events and nine hazardous material incidents


#### Community Outreach:

- Provided tours of the Emergency Operations Center
- Provided community awareness programs through avenues such as Citizen's Police Academy, Lamar University's Practicum in Policing, Clergy and Police Partnership. Also hosted four LIT students for the Regional EM Internship program.
- Assisted the Gift of Life Program


### Training:

- Trained 30 Dispatch personnel in on-line in-service training; totaling 8,640 hours.
- Provided an additional 840 hours of specialty training to 105 tele-communicators and officers from Beaumont and regional agencies. Some notable topics included: The Resilient Dispatcher, When High Impact Calls have Impact, Being the Best, Basic Instructor, Hostage Negotiation, Texas Crime Information Center /Texas Law Enforcement Telecommunications System.
- Reimbursed \$28,000 for training and equipment from South East Texas Regional Planning Commission.

### Intelligence-Led Policing

Information shared with local, state and federal law-enforcement agencies enables the Beaumont Police Department to effectively combat and solve crime. Intelligence-led policing is an approach based on improved intelligence operations, community-oriented policing and problem solving. Partnerships with other agencies provide tools to identify, dismantle and prosecute crime rings that might otherwise require overly complex investigations. The department currently maintains working relationships with these agencies:
















### Traffic Unit

This unit enforces traffic laws, investigates all traffic related fatalities and follow-up investigation of hit and run crashes. The unit is responsible for wrecker and taxi inspections as well as parade permits. In 2021, the Traffic Unit had 40 callouts: 25 fatality crashes resulting in 28 deaths, 9 homicide scenes, 5 crashes with no fatalities, 1 assist of another agency (with DPS on fatality crash).




### Special Assignments Unit

# **Criminal Investigation Division**

# Auto-theft task force



Through a collaboration of jurisdictions and agencies, this unit covers the areas of Jefferson, Orange, Hardin, and Jasper Counties. The task force investigates auto-related crimes and attempts to identify local, regional and statewide crime trends. Through the involvement of the Beaumont Police Department, the Port Arthur Police Department, the Jefferson County Sheriff's Office, and the Hardin County Sheriff's Office, the task force encourages public awareness about auto theft prevention.

# Crime Scene Unit (ID) This unit is comprised of five highly trained civilian crime scene technicians.

With the supervision of a Sergeant, these civilians work alongside detectives to document, collect evidence, and aid in investigation of criminal offenses. The unit also houses the regional AFIS (Automated Fingerprint Information System) terminal.

### NIBIN—National Integrated Ballistic Information Network

Similar to a person's fingerprint, guns leave behind unique markings on bullet casings. NIBIN scans these markings and imprints to attempt to link cases and identify suspects. As soon as the Property unit obtains a casing, the ID unit has 48 hours to enter those casings into NIBIN. When a gun is confiscated, ID also enters the casings from test-fire rounds shot with the gun by Beaumont officers. The more entries into NIBIN, the stronger the database becomes. In 2021, Beaumont ID unit entered 500 casings, resulting in 95 leads.



Port Arthur Police Department and ATF (Bureau of Alcohol, Tobacco, Firearms and Explosives) also utilize Beaumont Police Department's NIBIN system. Any agency is welcome, as long as they are trained. Recently, two ID civilians were certified as NIBIN trainers. They are beginning to train the other ID employees at BPD.







# **Family Violence Unit**

This unit investigates domestic violence cases.

Detectives within this unit work with families to break the cycle of domestic abuse. Through working with various agencies like Family Services of Southeast Texas and Jefferson County Crime Victim's Assistance, they help victims and families develop strategies to escape and avoid abusive situations in the future.

### Narcotics/VICE Unit

Any violation or offense involving prostitution, gambling, or firearms is handled by this unit. The unit uses undercover buys of narcotics and surveillance to develop criminal cases.

# **Property Crimes Unit**

This unit investigates stolen or damaged property. Three sub-units function within the Property Crimes Unit: Burglary, Financial Crimes, and Theft and Criminal Mischief.

Burglary investigates both residential and commercial burglaries where a building is entered without permission to commit theft or other offenses. They were assigned 336 cases in 2021.

Financial Crimes investigates credit card abuse, identity theft, and counterfeit/forged checks and currency. They were assigned 646 cases in 2021.

Theft and Criminal Mischief investigates crimes where property is stolen or damaged. They were assigned 1,163 cases in 2021.

# **Special Crimes Unit**

This unit investigates all crimes committed against and by juveniles aged 16 and under. These detectives also

investigate all sex crimes involving both juveniles and adults. The unit is responsible for the registration and compliance of 740 sex offenders in the Beaumont area. The unit partners with many local agencies including the Garth House, Southeast Texas Alliance Against Trafficking, Harvest House, Child Protective Services, and other local law enforcement.

# Persons Crimes Unit


The Persons Crimes Unit handles all violent crimes against persons 17 and older.



Detectives are assigned to all persons-related crimes, even when there is no known actor/suspect. This also includes homicides and officer-involved shootings.

In 2021, there were 18 homicides in the city of Beaumont. Of the 18, 14 of these were investigated by the Persons Crimes unit.

During the year, the Persons Crimes unit also investigated several older cases. Two of the cases solved were from the year 2020. One victim was recovered in Chambers County. The other involved a mother and her unborn child, who were were found in Calcasieu Parish, LA.



Another prominent case that was brought to a close was the 1994 murder of a local school teacher. Through DNA genealogy, a suspect was tracked down in Ohio, arrested, and extradited. Detectives in the Persons Crimes unit are responsible for investigating some of the most heinous of crimes. They are relentless in their investigations, as shown by their accomplishments in 2021. The Beaumont Police Department is proud of the Persons Crimes unit.






