The extent and nature of each persons interest in the corporation must also be detailed. A certified copy of the Articles of Incorporation and a certificate stating that the corporation is in good standing with the Secretary of State of Texas shall be submitted as a part of the application.

Vehicles

The applicant is required to submit, as a part of the application, a current copy of the certificate of registration issued by the Texas Department of Licensing and Registration (TDLR) or Texas Department of Transportation (TXDOT) for a towing company and each tow truck to be operated by the towing company. Additionally, the applicant shall file with the application a title application receipt and registration documents for each tow truck to be used in the course and scope of operation of the towing company. The applicant shall also attach documents demonstrating that each tow truck is properly insured pursuant to the statutes, administration code and related regulations of the State of Texas with an accompanying certificate issued by an insurance company licensed in the State of Texas stating that they will notify the Beaumont Police Department at any time the certificates on insurance expires or are suspended or revoked for any reason.

An applicant shall submit, on an attached document, a tow truck inspection form for each tow truck to be used in the operation of the business for which this application is submitted. Identification markings on all tow trucks shall comply with Beaumont Ordinances and the State of Texas Statutes and Administrative Codes and regulations of the United States Department of Transportation Regulations related to Identification of tow trucks.

If the tow truck is to be operated under the name of a company other than the owner, then that company shall be also noted on the application. Accompanying the application shall be signed, notarized copy of the agreement and contract between the owner and the company in whose name the tow truck is to be operated.

I/ We, the applicant(s) for the permits as noted above, hereby certify that I/We have read and are familiar with the provisions of Article IV Wreckers, of Chapter 29, Vehicles for hire, Code of the City of Beaumont.
